PANDEMIC FLU – ISSUES FOR GPs

SWINE FLU CLINICAL PACKAGE

The Department of Health (DH) has recently produced a *Swine Flu Clinical Package*.

The swine flu clinical package is a set of tools for use in a pandemic situation by frontline healthcare professionals. It has been designed to:

- be used during the phase of a pandemic when there is increased demand for clinical care (further information on when these tools should be deployed will be given nearer that time).
- support and empower GPs, community nurses, midwives, health visitors, ambulance crews, emergency department doctors, nurses and those working outside their usual specialty area (eg junior doctors or surgeons working in influenza cohort wards).
- assist these health care professionals to assess patients, authorise antivirals, refer those with severe illness or complications, and guide treatment of patients in hospital.
- help with the face-to-face application of the guidance

Pandemic flu: managing demand and capacity in health care organisations (surge). It is therefore recommended that both documents are read in conjunction with each other.

**REGISTER OF GP AREAS OF
EXPERTISE**

**AUDIT OF GP ULTRASOUND
REQUESTS**

As part of service commitment a review of the requests for musculoskeletal ultrasounds by GPs was performed.

The request card was reviewed and the clinical information assessed to review the adequacy of information and the indications for the test requested. A sample of 50 requests was reviewed.

58% of the requests were for soft tissue lumps and 30% were of Morton's Neuroma, the remainder were other musculoskeletal indications including shoulder ultrasound.

In all cases the clinical information was detailed with the correct indications for the test requested, which shows high quality of referral information from the GPs.

The results of the test were also analysed, showing a relatively high pickup of abnormalities - 50% for Morton's neuroma and 90% for lumps and bumps. Of course, in some cases, a normal examination is reassuring and also clinically important.

In conclusion GPs are requesting appropriate ultrasounds for musculoskeletal patients with a high clinical pickup which will hopefully aid clinical management.

Ultrasound is the correct investigation in cases of suspected lumps and bumps, Tendon pathology or Morton's neuroma.

**CONFIRMATION AND
CERTIFICATION OF DEATH**

The GPC has recently updated their guidance *Confirmation and Certification of Death*, which clarifies the distinction between confirming and certifying death in relation to GPs' obligations.

This guidance covers:

- Legal requirements.
- Unexpected ("sudden") deaths.
- Expected deaths.
- Problem situations.

DEVELOPING GENERAL PRACTICE: LISTENING TO PATIENTS

In March 2009 *Developing general practice: Listening to patients* was put out to consultation, asking GPs and stakeholders to share their experiences of developing and improving their non clinical services.

The intention was to share best practice among the profession.

The outcome of the consultation was published in June 2009.

The document:

- encourages practices to focus on 'customer service';
- contains innovative examples of how GPs have developed services for their patients;
- offers advice on how GPs can best manage opening times and their often complex appointment systems;
- suggests the development of practice charters;
- encourages GP practices to set up Patient Participation Groups (PPGs).

LOOK AFTER OUR NHS

On 1 June 2009 the British Medical Association (BMA) launched its *Look After Our NHS* campaign in order to gather examples from doctors of ways in which market-driven reform is impacting on the NHS.

The BMA is concerned that some of the current health reforms, particularly those relating to the market, are moving the NHS away from its founding principles of being publicly funded, publicly provided

and publicly accountable. They have drawn up 8 principles for the NHS that they wish to promote and are asking for examples of how the reforms have affected GPs, their work and/or their patients.

MEDICAL (FACTUAL) REPORTS: A GUIDE ON COMPLETION

The LMC has received a number of queries regarding requests from the Department for Work and Pensions (DWP) for completion of medical reports.

Non-medical decision makers use medical reports when deciding benefit entitlement and, when needed, seek advice from a healthcare professional trained in disability assessment medicine. The reports may also be used if a patient appeals against a benefit decision.

Guidance for healthcare professionals entitled *DWP Medical (Factual) Reports: A Guide on Completion* covers issues such as:

- Why does the DWP request reports?
- Who uses the report?
- Will the information be used?
- Relevant forms
- Computer Printouts
- Contractual Obligations
- Consent
- Release of Information
- Harmful Information
- Rehabilitation of Offenders Act
- Delegation of completion of reports

LICENSING OF GPs: RESPONSE DEADLINE

As you will be aware, from 16 November 2009 any doctor wishing to practise medicine in the UK will, by law, need to hold both registration and a licence to practise.

Doctors who have not yet told the General Medical Council (GMC) whether they will require a licence when licensing begins in November are being asked to make their decision by Friday 14 August 2009.

The GMC will be writing to those doctors who have not yet responded to the 'Licensing: it's time to decide' campaign.
