#### OUT PATIENT PRESCRIBING

A number of concerns have been raised with the LMC regarding changes being implemented at Sheffield Teaching Hospitals NHS Trust (STHFT) in relation to out patient prescribing.

Richard Oliver, Joint PEC Chair, wrote to practices in May 2010 clarifying a number of issues, such as the reasons for the changes, the specialties involved, agreements in place etc. Of particular note is the agreement that specialties could only join the out patient prescribing scheme if they could meet the criteria for rapid communication, as detailed in Richard Oliver's letter.

#### NEW TAX BRACKETS

The Finance Act 2009 introduced significant changes affecting those earning over £100,000, which came into effect on 6 April 2010, including:

- a new additional rate of income tax of 50% on total income (including all income, not just wages, salaries and profits) over £150,000;
- the gradual withdrawal of the personal allowance for those whose adjusted net income exceeds £100,000. The personal allowance will be reduced by £1 for every £2 of income in excess of the £100,000 threshold.

Recently revised GPC guidance Focus on the New Tax Brackets highlights the effects of the tax changes which will affect doctors earning over £100,000, and other financial considerations arising as a result. A spreadsheet illustrates the financial implications of taking on a salaried GP. A Mazars LLP letter report and the General Practitioners Defence Fund Limited (GPDF) disclaimer have been added, both of which are integral to a proper understanding of this guidance and of its accompanying schedules, which are presented for illustrative purposes only.

It should be noted that the guidance is not comprehensive; members should consider their own case in the light of their personal circumstances and **take advice where necessary from an accountant**.

#### **TREATMENT AND CARE TOWARDS THE END OF LIFE**

The General Medical Council (GMC) has produced guidance that came into effect on 1 July 2010.

The guidance encourages doctors to discuss ahead of time what treatment and care patients want towards the end of their life. It advises that, while doctors will not be expected to provide treatments that have no clinical benefit, or that could do harm, terminally-ill patients should have the final say on their treatment when the risks and benefits are finely balanced. However, doctors can withdraw treatments that are not of overall benefit to the patient.

The guidance expands on the guidance *Consent, patients and doctors making decision together,* which sets out the principles on which good clinical decisions should be based, and provides a framework for good practice when providing treatment and care for patients who are reaching the end of their lives. #### RESPONDING TO PATIENT REQUESTS RELATING TO ASSISTED SUICIDE

All forms of assisted dving (euthanasia and assisted suicide) are illegal in the UK. The Crown Prosecution Service (CPS) in England looks at individual cases to ascertain whether a prosecution should be brought. Decisions taken by prosecutors are now guided by the factors outlined in definitive guidance published by the CPS and PPS in February 2010.

In response to enquiries about where the boundaries lie, in terms of what it is or is not permissible for doctors to do in response to patient requests relating to assisted suicide, the BMA has recently produced guidance for doctors. The guidance covers the guidelines for prosecutors on assisted suicide, the current legal position, and how doctors should respond to patient requests relating to assisted suicide, including those involving patients travelling abroad to obtain assisted suicide.

#### NHS OPERATING FRAMEWORK REVISION

The Department of Health (DH) has published *Revision to the Operating Framework for the NHS in England in 2010/11*, which sets out changes that need to happen in this financial year and those areas where change can be expected in the NHS Operating Framework 2011/12.

Some changes include the removal of targets around access to primary care, the removal of top-down performance management of the 18 weeks referral to treatment target and a reduction of the 4 hour A&E target threshold from 98 per cent to 95 per cent.
