In order to encourage as wide an electorate as possible, the 2020-24 election process will remain in a paper format. It is proposed that future elections will be undertaken in an electronic format.

A nomination paper is enclosed, which candidates need to complete and return to the address given. Please do not return nomination papers to the LMC office.

Please note that **nominations must be received by Friday 9 October 2020.**
