GP CONTRACT CHANGES 2013/14

On 6 December the GPC received a letter containing details of the proposed imposition of changes to the General Medical Services (GMS) contract 2013/14 for England, which was shared with the profession the following day.

Analysis of the imposition documentation has taken place and on 9 January 2013 the GPC issued tools and guidance for practices, with the intention of helping GPs to understand the potential impact of the proposed changes.

The information, available at <u>http://bma.org.uk/gpcontract</u> includes:

- A step-by-step guide setting out all the detail GPs need to assess how the changes will affect them, how these changes came about and an analysis of what they mean.
- A ready reckoner to estimate how much practice funding will be affected by the Quality and

Outcomes Framework (QOF) proposals.

The British Medical Association (BMA) has until 26 February 2013 to respond to the government's consultation in detail.

CONSULTATION ON QOF INDICATORS

As part of the QOF process, the National Institute for Health and Clinical Excellence (NICE) is encouraging stakeholders to comment on potential new indicators for consideration for the 2014/15 QOF.

There are 14 potential new indicators across the following six domains:

- Hypertension
- Dementia
- Coronary heart disease (CHD)
- Diabetes (including tightly linked measures)
- Peripheral arterial disease (PAD)
- Stroke and TIA

The results of the consultation will be considered by the Primary Care QOF Indicator Advisory Committee in June 2013, following which recommendations will be made as to which indicators should be included on the NICE menu for consideration for the 2014/15 QOF. REORGANISATION OF COMMUNITY NURSING TEAMS

As reported in the last edition of the LMC's Activity Update, Primary and Community Services representatives attended a meeting of the full LMC in 2012, following which a number of concerns raised at the meeting were followed up. Of particular concern were changes in community nursing teams and communications with practices.

Reassurances have since been received that it is the Primary and Community Services aim that either the service manager or the nurse team leader will discuss with the GP practices any proposal to move the community nursing team and arrangements will be put in place to ensure communication between practices and community nursing teams continues effectively.

Despite these reassurances, a number of practices remain concerned that they are not being adequately consulted and that channels of communication will deteriorate. LEGAL AID CUTS AND VICTIMS OF DOMESTIC ABUSE

Further to the article in the December LMC newsletter, we have now received confirmation from Taylor&Emmet Solicitors that other areas have raised concerns regarding the request for an examination and short medical report on patients who are claiming to be victims of domestic violence.

As in Sheffield, Taylor&Emmet have been made aware that such requests fall outside of normal NHS contractual work.

In view of this being a national problem, Taylor&Emmet have contacted Resolution – First for Family Law, the representative body for family lawyers in England and Wales. Their director of communications has offered to discuss this issue with Sheffield LMC and Resolution will be making contact with the BMA.

Further updates will be issued as negotiations progress.

LOCUM SUPERANNUATION

The government is proposing that from April 2013 GP practices will pay locums' employer pensions contributions, which are currently paid by Primary Care Organisations (PCOs).

The GPC understands that the intention is that the funds would be moved into global sum.

This change would be introduced via amendments to the NHS Pension Scheme Regulations, which are currently being consulted on by the government.

The GPC is very concerned about the implications both for practices and for GP locums and the BMA will be responding to the consultation to express these concerns, as well as raising it via GPC negotiations with the Department of Health (DH).

HPV PRIMARY SCREENING FOR THE NHS CERVICAL SCREENING PROGRAMME (NHSCSP)

'HPV Primary Screening' refers to the Laboratory doing the test for HPV first, before considering if cytology is then required.

From the sample taker's and the woman's point of view there will be no change: the sample will be taken in the same way and sent to the laboratory for testing.

Instead of doing cytology using microscope, the first line test will be the HPV test.

If the test is negative, the woman will be returned to normal recall.

If the test is HPV positive, the sample will have cytology and any abnormal cases will be referred for colposcopy.

Sheffield is one of the six sites to be chosen to do this (before National roll-out), with a probable start date of April 2013.

The Laboratory will keep us all informed.
