PRIMARY CARE NETWORK (PCN) PREMISES REQUIREMENTS FOR ADDITIONAL WORKFORCE

A number of queries raised with the General Practitioners Committee (GPC) have highlighted the issue of practices requiring additional space for PCN activities.

As a Direct Enhanced Service (DES) of the GMS contract, PCNs are an extension of GP practices. The same rules should apply for PCN staff and premises requirements as for GMS. Any space utilised to provide PCN services should be treated as GMS space and treated similarly for rent reimbursements.

PRIMARY CARE SUPPORT ENGLAND (PCSE) SURVEYS

General Practitioners Committee (GPC) England ran a range of surveys in December 2017, which gave useful detail and evidence of the problems practice staff and LMCs were facing as a result of the service delivery of PCSE. The response was extremely helpful in the GPC's efforts to push NHS England to resolve these issues. There are clearly a large number of on-going problems with this service and, therefore, the GPC is repeating the surveys to gauge how things are now. This will enable the GPC to influence operational issues, as well as giving the GPC hard data to substantiate the anecdotal evidence they also receive.

DEBT AND MENTAL HEALTH EVIDENCE FORM (DMHEF)

Patients who have a mental health condition may ask their GP to complete a DMHEF, which will act as evidence and support them in seeking help with their repayment of finances.

A much shorter and simpler form was introduced on 1 October 2019 that can be completed by the following wider range of healthcare professionals:

- social worker;
- psychiatrist;
- general practitioner;
- mental health therapist.
- mental health nurse;
- psychologist;
- occupational therapist;

Following the introduction of an easier process, shorter form and a greater number of health care professionals to complete it, it was agreed that GPs in England can no longer charge a fee for completing the DMHEF. The agreement was reached on the basis that an improved process would be implemented to allow patients to self-certify and seek support from a wider range of healthcare professionals, thereby reducing the burden on GPs to complete this.

The front side of the new DMHEF simply asks for the professional to confirm the indebted person has a mental health condition and to give the name of this condition. GPs *may wish* to also complete the back of the form, but there is *no contractual obligation* or expectation to do this.

The DMHEF is accompanied by a consent form. Health and social care professionals should not complete the DMHEF without seeing a consent form from the indebted person giving their permission for this to happen.

There may be times when a more complex health report is required by a bank or other lender, and in those rare circumstances, those reports should be sought directly from the practice by a lender and the lender should pay an appropriate fee, not the patient.

PATIENT REGISTRATION: PROOF OF ID / ADDRESS / IMMIGRATION STATUS

Information circulated at the request of Dr Louise Millington, Inclusion Health Champion Sheffield

Concerns have been raised regarding the inconsistent patient registration policies in place in general practice.

Anyone, regardless of nationality and residential status may register and consult with a GP without charge. Whilst it is helpful if a patient has some form of documentation, there is no regulatory requirement to prove identity, address or immigration status in order to register as a patient, and there is no contractual requirement for GP practices to request this information.

OVERSEAS VISITOR CHARGING

The General Practitioners Committee (GPC) has been made aware that NHS Trust Overseas Visitor Managers (OVMs), staff members responsible for charging overseas patients for NHS treatment in hospitals, have written to local GP practices requesting their help in identifying whether patients are eligible for free NHS care. Specifically, the OVMs have asked GPs to note on referrals that patients are 'overseas visitors' if they have been resident in the UK for less than 6 months.

The GPC has confirmed that this is absolutely not a GP's responsibility and there is no requirement to do so. Guidance from the Department of Health and Social Care is explicitly clear that the responsibility for determining a patient's eligibility for NHS care lies with the Trust and never with a GP or GP practice:

The guidance also clarifies that the GMS1 supplementary questions regarding a patient's eligibility for free care are not required to be completed before a patient can register with a GP practice, and that this should be made clear to prospective patients.

FLU VACCINATIONS - GP PRACTICE STAFF MEDICAL DEFENCE ORGANISATION (MDO) POSITION ON INDEMNITY

Following concerns raised about indemnity cover provided for the provision of flu immunisations to practice staff, the General Practitioners Committee (GPC) has been in discussion with NHS England, Public Health England and the MDOs.

The Medical Defence Union (MDU) provided the following clarification:

"Our current position on flu vaccinations is that we understand some practices may find it easier to provide flu vaccinations for staff themselves and want to help them to do that. We make no extra charge for indemnity for members whose practices provide flu vaccinations to staff as this is already within the benefits of membership for GP members. We encourage members who want to administer flu vaccinations to staff to contact us and advise the following: We advise members administering flu vaccinations to staff to follow their normal procedures for dealing with unregistered patients and to ensure they make a full assessment of each staff member's suitability for the vaccine, for example, ruling out contraindications. Consent should be obtained in the usual way as for registered patients. Notes should be kept and, assuming the staff member agrees, their normal registered GP should be advised that they have had the vaccination."

Subsequently, the MDOs have all provided the GPC with reassurance that all current members will be indemnified through them for this activity. Any GPs that are in any doubt about any of their indemnity arrangements are advised to contact their MDO directly.

Following publication of the National Audit Office report into NHSPS in June, the PAC - a committee of MPs scrutinising public spending - heard from senior officials at NHSPS, NHS England and the Department of Health & Social Care, who answered questions on how the service is managed and what action can be taken to improve how it manages its tenants.

The British Medical Association (BMA) submitted written evidence to the committee highlighting the significant increases to service charges to GP practices without their agreement and the impact this is having on the profession:

The BMA was concerned by comments made by NHSPS during the hearing in relation to the BMA's position on GP leases. NHSPS stated that a template lease was agreed with the BMA which the BMA shared but subsequently 'retracted' support for, which is not the case.

The BMA did and continues to support the principle of lease agreements between NHSPS and practices, and continues to host the lease template letter on their website:

HOME OFFICE FIREARMS CONSULTATION RESPONSE

On 17 September the British Medical Association (BMA) and the Royal College of General Practitioners (RCGP) submitted a joint response to the Home Office consultation on statutory guidance to police on firearms licensing: https://www.bma.org.uk/media/files/pdfs/employment%20advice/ethics/joint%20response%20to%20home%20office%20consultation%20guidance%20to%20police%20firearms%20licensing.pdf?la=en

The BMA and the RCGP have worked collaboratively with the Home Office and other key stakeholders including the National Police Chiefs Council to improve the system for firearms licensing with the core aim of improving safety for the public whilst also recognising the professional and resource implications for doctors.

The response includes a significant number of changes that the BMA / RCGP believe would be helpful to ensure that the guidance can be effectively implemented at a local level by police authorities. The priority has been to provide a response in sufficient detail that the perspectives of frontline GPs can be fully recognised, particularly as this consultation is in relation to statutory guidance.

NHS PENSION SCHEME CONSULTATION

While the British Medical Association (BMA) is clear that this is not a long-term solution to the problems facing doctors, in the short term any flexibility proposals must include full recycling of employer contributions. The long-term solution is pension taxation reform.

LEARNING DISABILITY REGISTERS

NHS England (NHSE) has published new guidance for practices to ensure that learning disability registers are comprehensive and up to date and vulnerable patients are given the opportunity to receive flu vaccinations and annual health checks: https://www.england.nhs.uk/wp-content/uploads/2019/10/improving-identification-of-people-with-a-learning-disability-guidance-for-general-practice.pdf

The General Practitioners Committee (GPC) is encouraging practices to use this guidance to regularly review their learning disability registers to ensure they are up to date so that the right patients are being invited to attend vaccinations and health checks. However, the GPC has raised concerns with NHSE about the significant amount of GP time that it will take to manually update registers to include all of the conditions listed and are pressing NHSE and NHS Digital to commission an automated system as soon as possible. Meanwhile, where diagnosis of a learning disability is unclear, GPs should refer for a specialist assessment.
