#### ***ELECTED MEMBER VACANCY ON SHEFFIELD LMC***

Due to the recent relocation of two committee members, there are vacancies on the LMC for the remainder of the current electoral term, ie until 30 November 2012.

The number of sessional GPs on the committee has now reduced significantly, and the LMC Executive would be particularly keen to encourage sessional GPs to join the LMC. However, all eligible GPs (on Sheffield Medical Performers List and contributing to the LMC's levies, either directly or via practice contributions) are encouraged to consider joining the LMC.

Meetings of the full LMC are usually held on the second Monday of the month at 7.45 pm in the Lecture Theatre at Tapton Hall (occasionally dates are changed to avoid bank holidays, staff leave etc).

In addition, members are encouraged to represent the LMC on other committees and this additional meeting attendance is

funded by the organisers of the committees or the LMC.

The LMC's primary function is to represent Sheffield GPs and, therefore, it is extremely important that local GPs have a means of debating the important topical issues and influencing or making policy in order to represent the breadth of general practice in Sheffield.

The LMC is also a very useful forum for keeping up-to-date with all that is happening in Primary Care and a chance to meet colleagues with differing views across the city.

### **SEASONAL FLU VACCINATION PROGRAMME FOR 2011/12**

The General Practitioners Committee (GPC) has written to all GPs to remind them of the arrangements for the seasonal flu vaccine programme in 2011/12.

Evidence shows that patients in at-risk groups are much more likely to die from seasonal flu than healthy individuals.

Given that the seasonal flu vaccine uptake in the at-risk groups in patients under 65 and pregnant women was much lower last year than that recommended by the World Health Organisation (WHO), the GPC is encouraging practices to ensure that those in the at-risk groups are given priority.

The GPC is also concerned about the low uptake in healthcare workers, and is encouraging practices to ensure that staff are better protected.

### **CARE QUALITY COMMISSION (CQC) REGISTRATION**

Following the recent consultation, the Department of Health (DH) has formally announced a delay to the registration of GP practices with the CQC until April 2013, subject to Parliamentary approval.

Whilst the announcement is welcome, the General Practitioners Committee's (GPC) view remains that:

- the intervening period should be used to radically reduce the requirements for compliance on GP practices;
- practices should not undertake any significant preparatory work relating to registration at this stage;
- practices should not engage others to undertake any significant preparatory work for them, as these third parties cannot possibly know what the final CQC process will include.
