SHEFFIELD CITY COUNCIL

We have maintained links with Sheffield City Council (SCC) in a variety of areas over the years. If there are any issues that GPs/Practice Managers feel it would be useful for the LMC to liaise with SCC about, please email the LMC office via manager@sheffieldlmc.org.uk.

<u>Chlamydia Screening Pathway and the Introduction of Universal Dual Testing:</u> We were consulted on, and had no concerns with these proposals. Our only request was that copies of results received in general practice for information are clearly marked as such, avoiding any misunderstanding as to who is going to action any noted treatment or follow-up.

SHEFFIELD CCG/COMMISSIONING EXECUTIVE TEAM (CET)

LMC Executive and Secretariat representatives met with CCG and CET representatives to discuss issues of mutual interest or concern, which included the Quality Premium, Unscheduled Care Working Group, Avoiding Unplanned Admissions Directed Enhanced Service (DES), e-referral pilot, quality of e-discharge communications, withdrawal of funding for occupational health and co-commissioning in primary care. Where issues require more time and consideration than is practical at the monthly meetings, more detailed negotiations take place. Our recent negotiations include:

Quality Improvement Scheme (QIS): We voiced concerns about the number of elements that it was proposed would make up the QIS and the workload involved in completing yet more audits and were pleased to see some modifications to the proposal. However, these did not address all of our concerns, the main ones being that all of the work had to be undertaken in order to receive any payment and that there was a danger that completion of the QIS could become more of a box ticking exercise than a guarantee of improved quality. Further concerns were brought to our attention once the finalised document had been distributed to practices and we continue to discuss these with the CCG.

<u>Care Homes Locally Commissioned Services (LCS)</u>: A number of practices have contacted us with concerns about the in-year contract changes in relation to this LCS. We understand there has been some further amendments to address some of these concerns, but we continue to communicate with the CCG on this in order to represent practices' views adequately.

<u>Commissioning of Sexual Assault Referral Centres</u>: We submitted our comments on this consultation and have sought reassurances about the services that are to be made available for children.

SOUTH YORKSHIRE AND BASSETLAW (SY&B) LMCs AND NHS ENGLAND SOUTH YORKSHIRE AND BASSETLAW AREA TEAM

We continue to meet regularly as SY&B LMCs, as well as with the Area Team. The main topics recently have been the 2014/15 budget plan for Primary Care, co-commissioning in primary care, late/incorrect payments to GP practices, capital bids, delivery of the seasonal flu vaccination programme, complaints handling, withdrawal of funding for occupational health services and Transforming Primary Care Support (PCS) Services.

Where issues require more time and consideration than is practical at these meetings, more detailed negotiations take place. Our recent negotiations include:

<u>Withdrawal of the Minimum Practice Income Guarantee (MPIG) and Personal Medical Services (PMS) Contract Review</u>: We continue to make representations to the Area Team, work with local practices and liaise with the General Practitioners Committee, in the hope that the process of moving to equitable funding does not have any avoidable negative impact on Sheffield practices and the services that can be provided to Sheffield patients. An agreement has yet to be reached on the timescale and principles for all of the changes and we hope that such detail can be agreed and shared with practices shortly.

MISCELLANEOUS MEETINGS/NEGOTIATIONS

Sheffield LMC and Sheffield Local Pharmaceutical Committee (LPC): We met with our pharmaceutical colleagues to discuss issues of mutual interest or concern such as changes to Stop Smoking Services, Sexual Health Services and Any Qualified Providers (AQPs), Drug and Alcohol Strategy, GP Electronic Prescription Ordering, Electronic Prescription Services (EPS) 2, Distance Selling Pharmacies and Unavailable and Short Stock Medicines.

Frequent ad hoc meetings and negotiations take place, which are too numerous to mention individually. However, the main topics we have held negotiations on recently are:

- Withholding/displaying practice telephone numbers;
- Availability of ritual circumcision;
- Requests for medical reports from the Combat Stress Welfare Support Team;
- Managing housebound anticoagulation patients;
- Lasting Powers of Attorney;
- Mental Health Action Group Sheffield requests for GP referral forms;
- Patient Participation Directed Enhanced Service (DES) Appeals;
- Paperless referral pilot;
- Hospital doctors issuing fit notes;
- Transport to hospital outpatients;
- Interpreter services;
- Provision of prescriptions for Monitored Dosage Systems (MDSs);
- Prescribing intervals;
- Vitamin D prescribing;
- Travel vaccination provision and funding.
