HEART FAILURE: PRESCRIBING OF BETA BLOCKERS

Negotiations have been held at Area Prescribing Committee (APC) meetings with the Sheffield Teaching Hospitals NHS Foundation Trust (STHFT), with regard to inconsistency in prescribing beta blockers for heart failure by consultants within STHFT and guidance for GPs using beta blockers in heart failure according to QOF criteria. There is now an agreement that STHFT will switch patients to Bisoprolol and Carvedilol on discharge. This is with the provision that a small number of elderly patients with clinical need will be maintained on a small dose of Metoprolol instead.

BUSINESS RATES REVIEW

Following NHS Sheffield's decision to undertake a business rates review, concerns were raised regarding any link between business rates and future notional rent inspections. FIT FOR THE FUTURE – THE EVOLUTION OF GENERAL PRACTICE

The GPC has produced a fifty point plan for the future of general practice in the UK. *Fit for the Future – the evolution of general practice* makes recommendations for improvements in a number of areas including outof-hours care, the Quality and Outcomes Framework (QOF), workforce and information technology.

Recommendations in the report include:

- Increase the role of general practice in promoting public health.
- Increase patient involvement in the planning and arranging of services.
- Improve management, at a national level, of the GP workforce, in order to avoid shortages of GPs in areas which find it difficult to recruit.
- Replace PFI projects with a new scheme to support sustainable practice developments.
- Increase involvement of GPs in the commissioning of out-of-hours services.
- All contract holders (eg GP partners or private companies) should have day-to-day involvement in the running of their surgery to ensure there is a firm commitment to local health services.

Reviewing PMS Contractual Agreements – Guidance Update

This is an update of the GPC guidance issued to PMS and APMS contractors providing essential services in April 2006 and March 2007. This guidance sets out the options available to PMS practices when PCTs seek to change PMS contracts. There are four options for practices facing a review of their PMS contract, outlined under the following headings:

- Seek to retain current contractual status with no changes.
- Renegotiate PMS contract.
- Transfer to GMS.
- Transfer to a new, locallynegotiated, APMS contract.

THE EXTENDED HOURS ACCESS SCHEME 2010

The GPC and NHS Employers have agreed that the Extended Hours Access Scheme will continue for a further year from 1 April 2010. The main changes from the existing arrangements will be that practices will be required to indicate by 30 June 2010 whether they are proposing to participate in the new Extended Hours Access Scheme in 2010/11. USE OF PREMIUM RATE NUMBERS IN THE NHS

On 21 December 2009 directions were issued concerning the cost of telephone calls, which meant that the use of phone numbers that charge the public or patients a premium rate to contact the NHS were banned in England, but that 084 numbers could continue to be used if call charges were no more expensive that those of the equivalent local calls.
