The General Practitioners Committee (GPC) has recently confirmed the outcome of discussions between the British Medical Association (BMA) and the Association of Chief of Police Officers (ACPO) on this issue. In addition, the BMA Ethics Department has issued guidance. As a result, the LMC has produced guidance summarising and linking to the information currently available to assist GPs who are asked to certify a patient's fitness to hold firearms or to countersign a shotgun certificate application. The GPC has responded to the consultation, welcoming the proposed delay, but making it clear that they expect the delay to be used to radically reduce the compliance requirements on GP practices. QOF FREQUENTLY ASKED QUESTIONS

SAFEGUARDING VULNERABLE ADULTS

The BMA has recently published Safeguarding vulnerable adults - a toolkit for general practitioners. This toolkit provides practical advice doctors on promoting protecting the wellbeing vulnerable adults. The term vulnerable adults covers an extremely wide range of individuals, some of whom may be incapable of looking after any aspect of their lives and others who may be experiencing short periods of illness or disability with an associated reduction in their ability to make decisions.

The toolkit highlights the obligation doctors have to protect vulnerable adults, including identifying abusers, identifying systemic healthcare and failures reporting performance by health professionals. It includes examples of good practice and signposts key guidance, relevant legislation and useful names and addresses. The guidance covered includes:

- What is safeguarding?
- Which adults may be vulnerable?
- What constitutes abuse and neglect?
- What part does mental capacity play in safeguarding?
- Adults lacking capacity.
- Care and treatment amounting to deprivation of liberty.
- When can information be shared about vulnerable adults?
- What part does good communication play in safeguarding?
- How can safeguarding adults be made part of ordinary care?
- When should GPs refer through multi-agency safeguarding adults' service?
- When should concerns about patient safety be reported?

PROVIDING MEDICAL CARE AT SPORTING EVENTS

The BMA's Board of Science has published an updated version of its resource for doctors providing assistance at sporting events. The

aim of this resource is to provide information for doctors who are interested in providing medical care at sporting events in a professional (whether paid or unpaid) capacity. In it emphasises particular, importance of a doctor contacting their medical defence organisation prior to assisting or providing care at a sporting event. This resource was first published in 2001, with an updated version in 2009. This latest edition, published in August 2011, includes specific guidance for doctors providing medical care at the 2012 Olympic and Paralympic Games.
