The LMC's primary function is to represent Sheffield GPs and, therefore, it is extremely important that local GPs have a means of debating the important topical issues and influencing or making policy in order to represent the breadth of general practice in Sheffield. It is also a very useful forum for keeping up-to-date with all that is happening in Primary Care and a chance to meet colleagues with differing views across the city.

SAFEGUARDING CHILDREN, OFSTED AND CQC VISITS

As it is about 3 years since the last inspection, Sheffield will soon be due for an Office for Standards in Education, Children's Services and Skills (OFSTED) visit.

OFSTED looks at all organisations, but they mainly concentrate on the Social Services performance with regard to safeguarding and Looked after Children (LAC).

OFSTED will be accompanied by the Care Quality Commission (CQC). The CQC will review NHS systems and protocols with regards to safeguarding and LAC. Both organisations will look into the details of about 20 children (half safeguarding, half LAC). They are also likely to include recent serious case reviews.

GPs, surgery staff and attached staff may be asked to attend for interviews, or to demonstrate their safeguarding procedures. It is important that primary care personnel do their best to comply with these requests. The CQC have the right to ask to see practice protocols. They can also see the medical notes without requiring consent but, apparently, seldom exercise that right.

YOUR CHOICE OF GP PRACTICE

The Department of Health (DH) has published *Your choice of GP*

practice: a consultation on how to enable people to register with the GP practice of their choice.

This consultation:

- is seeking views from the public, healthcare professionals and other staff working in the NHS on new proposals that give patients a greater choice of GP practice.
- sets out the different options for organising healthcare for patients, and the potential implications of their choices if the current system of GP practice boundaries is removed.
- will close on 28 May 2010.

SUMMARY CARE RECORD

The GPC has recently produced guidance due to the roll out of the Summary Care Record (SCR) across a number of strategic health authorities (SHAs).

The guidance represents the GPC's views and clarifies the GPC's position. The main topics covered include:

- What is the SCR?
- What is the consent model for SCR?
- What information will patients receive?
- Should the GP practice play a role in informing patients about the SCR?
- What action should I take if the SCR is being rolled out in my area?
- Will the SCR generate extra work?
- How have the BMA and GPC been involved in the development of the SCR?

SAFETY ALERTS IN GENERAL PRACTICES

The LMC Executive have seen the DatixWeb Safety Alert software being used by NHS Sheffield and agree that it is straightforward to use, should improve the distribution of alerts and make responding easier.

The software holds the original alert, records e-mails and deadlines, and includes a drop down response menu to make the process easier for practices. It works on any computer able to access the Sheffield PCT intranet.

The plan is to use this system together with the new generic practice nhs.net e-mail addresses, eg sheff-pct.practiceMC@nhs.net.

It is for each Practice to decide on their internal process to ensure the alerts are accessed and responded to.

Training sessions will be arranged at 722 Prince of Wales Road and advertised by the PCT.

REQUESTS FROM SCHOOLS FOR SICKNESS CERTIFICATION

GPs are not contractually obliged to provide a sick note for pupils who are off sick from school. They are also not obliged to provide sickness certification for students that miss an exam or believe their performance was affected due to illness.

As GPs continue to receive requests from schools, the GPC wrote to the Office of the Qualifications and Examinations Regulator (Ofqual) and received confirmation that medical proof should not be required.

VAULT SMEARS

Within the national cervical screening programme, the

responsibility for follow-up vault smears has been shifted from GPs to the gynaecologists who performed the hysterectomy.

There are two main reasons for this shift:

1. It is essentially a post-operative follow-up issue, as if there has been incomplete excision of neoplastic changes, this will require further intervention by the gynaecologist;
2. There has been considerable difficulty in performing vault smears (knowing which part of the vault to smear and ensuring that the 'corners' of the scar are adequately sampled). This is very difficult to do properly in the primary care setting, so national advice is now that it should be done by colposcopic viewing and sampling, thus ensuring a good valid sampling and greater safety for the patient.

We are awaiting further national guidance and clarification on how this is being implemented locally.

HMRC CHILD BENEFIT OFFICE CONFIRMATION OF REGISTRATION

The LMC has received a number of queries regarding practices complying with HMRC Child Benefit Office requests for information, with particular concerns relating to the release of confidential information and patient consent.

Following communications with the Child Benefit Office and the GPC, the LMC has produced guidance for Sheffield GPs on this issue.

SICK NOTE TO FIT NOTE: STATEMENT OF FITNESS FOR WORK

In partnership with the Royal College of General Practitioners (RCGP) and the BMA, the Department for Work and Pensions (DWP) has developed guidance for GPs on the new Statement of Fitness for Work.

On 6 April 2010, the current Forms Med 3 and Med 5 will be replaced with a single revised Statement of Fitness for Work.

The guidance covers issues such as:

- What is changing?
- What stays the same?
- Why change?
- Addressing work issues during consultations.
- Completing a Statement of Fitness to Work.
- Frequently asked questions.
- Case studies.
- Where to go for more information.

PAYMENT OF MEDICAL FEES FOR MENTAL HEALTH ASSESSMENTS

The LMC office has recently been made aware of a number of episodes where GPs have had difficulty in obtaining the appropriate fee for undertaking an assessment under the Mental Health Act.

It is the LMC's understanding that it is a GP's responsibility to ask the duty social worker for a copy of *Form C4/23 Request for Payment of Medical Fees* when completing the mental health capacity assessment.

There is a *Mental Health* line on the form which asks the GP to:

- state the Section Number;
- confirm if they are S12 Approved;
- fill in the amount of the claim.

If GPs are experiencing difficulty in acquiring these forms from the social worker at the time of the assessment, it would be appreciated if specific examples could be forwarded to the LMC office via:

ACCESS TO HEALTH RECORDS REQUESTS

The DH has recently produced this guidance, which aims to assist NHS organisations through the process of dealing with an access request in accordance with the relevant legislation and any subsequent consideration.

- Freedom of Information Act 2000.
- Access to Medical Reports Acts 1988.

IMPACT OF BUDGET 2009 ON PENSIONS - UPDATE

In his Budget on 22 April 2009, the Chancellor announced the introduction, from 6 April 2010, of a new additional rate of income tax of 50%, applying to taxable income over £150,000.

In order to prevent this resulting in an increase to the tax relief granted on pension contributions, the Chancellor also announced that from 6 April 2011, tax relief on pension contributions for high earners will be restricted.

The BMA has produced a briefing note that looks at the changes to tax relief on pension contributions, along with the 'anti-forestalling' measures that the Government has put in place to limit individuals who may otherwise have been tempted to maximise their tax relief by making additional contributions before 6 April 2011.

FUTURE OF GP PRACTICE PREMISES

This updated GPC guidance (originally issued in 2001) examines the current state and future of the various primary care premises development options available and describes the premises provisions of the GMS contract.

It incorporates GPC guidance on the premises costs directions and on the impact of the Disability Discrimination Act.

The main issues covered include:

- The drivers for change;
- Who should develop?
- Ownership and leasing - the risks and benefits;
- Multiple occupation;

- Factors influencing choice of ownership and procurement route.

SALARIED GPs' HANDBOOK 2010

The Salaried GPs' Handbook 2010:

- explains the legal entitlements of all salaried GPs as employees (therefore helping to ensure that salaried GPs are aware of their statutory and contractual rights, and helping to prevent GP employers unwittingly falling foul of the law).
- contains sections on topics such as how to become a salaried GP and the work involved.
- has been updated to take account of changes in employment law, as well as clarifying guidance from the previous handbook.
- includes new sections on maternity leave and redundancy, and updated information on many other areas such as salary, hours of work, sick leave and employment protection.
- was sent out to all salaried GP BMA members on 8 March 2010.

IB/ESA113 ELECTRONIC TEMPLATE

Most information requests regarding Incapacity Benefit (IB) and Employment and Support Allowance (ESA) claims will be on the IB/ESA113.

GPs are asked to complete this form if the DWP thinks that the patient may have a severe health condition or disability but they do not have enough information to be sure.

GPs no longer have to fill in the form by hand, as an interactive electronic version is now available.

BT PRIORITY FAULT REPAIR SERVICE (PFRS) TERMINATION

A national agreement is currently held with BT to provide a PFRS.

GP practices, as well as GP private residences may, or may not, knowingly use this service.

BT is discontinuing the service from 1 April 2010, with the exception of 999 emergency services.

NHS Connecting for Health (CfH) wrote to all PCTs in February 2010, stating that BT would be writing to each individual site currently registered with the BT PFRS service to inform them of the change.

1. the patient has an incurable illness;

3. the patient is registered at a designated practice (see above);
4. the request is to support the individual staying in their own home;
5. statutory services have first been approached.

Provided the above five criteria are met, Sarah will then organise the care.
