#### SHEFFIELD WEIGHT MANAGEMENT SERVICES

Following discussions with Sheffield Place commissioners, we have received further clarity on the Weight Management Services in Sheffield as follows:

#### Tier 2 Services

• Provided by Live Lighter, commissioned by Sheffield City Council.

#### Tier 3 Services

- Encompassing a Multi-Disciplinary Team (MDT) pathway with access to specialist weight loss medication unavailable in Sheffield.
- Sheffield Place commissioners have begun the tendering process to procure this service and are hopeful that Tier 3 services will be operational next year.
- We will update you when further specifics about this are available.

#### <u>Tier 4 Services</u> (bariatric surgery)

- No longer available through Live Lighter.
- We have been assured by Sheffield Place commissioners that any patient who has completed the Tier 2 programme is eligible for referral to Tier 4 services at Sheffield Teaching Hospitals NHS Foundation Trust (STHFT).
- Assuming the patient consents to the referral, the patient ought to be admitted onto the waiting list for surgery. Naturally, there is a long wait for surgery, but STHFT and the commissioners inform us that they are working to address this.
- The commissioners inform us that Live Lighter can refer patients who have completed Tier 2 onto Tier 4 services. Alternatively, GPs can refer patients directly to STHFT once they have completed Tier 2.

#### Post Bariatric Surgery Follow-up of Private Patients

- Where patients have procured their surgery in the private sector, the commissioners suggest that, where possible, patients are advised of the need to ensure private follow-up.
- The first 2 years of post-operative care should be purchased in advance of having surgery, as the NHS will not provide this care.
- In addition, we wish to make Sheffield GPs aware that, as this is uncommissioned work, it potentially falls outside the cover of the Clinical Negligence Scheme for General Practice (CNSGP). Therefore, GPs are advised to seek medicolegal advice from their Medical Defence Organisation (MDO) if they are considering undertaking any post-operative follow-up for patients returning from the private sector.
- GPs will be covered for the instigation of investigations where a patient falls ill, rather than for routine monitoring.

#### **DIGITAL FIREARMS FLAG**

Update from Nik Baksi, Senior Policy Advisor, British Medical Association (BMA)

The digital firearms flag was relaunched on EMIS Web (EMIS) systems on Monday 6 February. There was be no change with SystmOne (TPP), as this has been operating with the flag.

The digital marker and flag have been tested and brought before the BMA's Joint GP IT Committee since being taken down in July 2022. GPs should add the appropriate SNOMED code to a patient's record when they receive notification of a firearms certificate application or when a certificate is granted, and this will automatically add a marker to the patient's record. If a potentially relevant condition of concern is added to their medical record during the application process or after a certificate has been issued, an alert will pop up.

BMA guidance The firearms licensing process has been updated.

In regards to questions of 'should we be flagging firearms', since 2019 and the MOU signed between the BMA, the Home Office, and the Police Chiefs, we have suggested that doctors input the firearm code on the patient profile when a patient has applied for, or acquires, a firearm. Furthermore, if a patient presents with a condition which would preclude them from firearm ownership, we would recommend the doctor inform the local constabulary. However, licencing and the subject of who should hold a licence is strictly the responsibility of the police.

#### PATIENT REGISTRATION

We receive various queries regarding the contractual requirements / regulations around registering patients. The main principle is that anyone, regardless of nationality and residential status, may register and consult with a GP without charge.

The British Medical Association (BMA) has produced guidance which covers:

- Contract and regulatory conditions
- Declining a patient registration
- Homeless patients
- Patients with no immigration status
- Duty to provide emergency treatment
- Registering without proof of identity or address
- Tourists and overseas visitors
- Patients about to be released from the secure estate

# HEALTH EDUCATION ENGLAND (HEE) TRAINING CONTRACT

Further to the article in the <u>December LMC newsletter</u>, the General Practitioners Committee (GPC) has discussed this contract further with HEE. It has been agreed that practices do not need to sign it. The contract was introduced to formalise the payment mechanism for practices to be paid for training and supervision. However, the contract was not general practice specific and included much which applied to hospitals.

The GPC has agreed with HEE that they will work on a more suitable contract for general practice and will keep LMCs updated when this is developed.

# COMMUNICATION BETWEEN THE DEPARTMENT FOR WORK AND PENSIONS (DWP) AND GP PRACTICES

To support the NHS move away from use of fax as a method of communication, and in response to the removal of fax machines from GP surgeries, the DWP has been working with the Centre for Health and Disability Assessments (CHDA) to respond to this change.

From 30 January 2023 CHDA moved to using email in place of existing fax processes for some communications with GP surgeries. The email will be in the format <a href="mailto:firstname.lastname@chda.dwp.gov.uk">firstname.lastname@chda.dwp.gov.uk</a> or <a href="mailto:location.furtherevidence@chda.dwp.gov.uk">location.furtherevidence@chda.dwp.gov.uk</a>. GPs should reply to the indicated <a href="mailto:location.furtherevidence@chda.dwp.gov.uk">location.furtherevidence@chda.dwp.gov.uk</a> email address.

The DWP has confirmed that this process meets information governance standards and is covered by existing data sharing agreements. Please note, as per the current arrangement, for all urgent information CHDA will call the GP surgery.
