PROVISION OF PINK CARD TEMPLATES

Agreement was reached some time ago regarding GPs not being required to complete pink cards. As cases of community nurses refusing to accept anything other than a pink card are still being reported to the LMC office, we sought assistance from Sarah Alton, Head of Medicines Management, Community Based Services at Sheffield Teaching Hospitals NHS Foundation Trust (STHFT). Sarah has kindly requested that the following message is cascaded to STHFT community nursing teams:

Sheffield GPs can now create a template of a pink card from their clinical systems using a software system called Ardens. It has been agreed that this Ardens template can be used as a source of information to transcribe onto the pink card in line with the community services transcribing procedure.

A mock- up of the template is attached above for reference. The template itself cannot be used in place of a pink card. If you receive this from a GP practice, please transcribe the information from the template onto a pink card and use in the usual way.

We recognise the future need for an electronic system and will continue to look into this, however this has not been progressed yet due to impending changes with Lorenzo.

In the meantime, if you have any issues or queries regarding the ARDENS template please let me know.

AMENDMENT TO ANNUAL FLU LETTER 2023/24

Further to the article in the <u>June LMC newsletter</u>, the government has confirmed an amendment to the <u>annual flu letter 2023/24</u>. It outlines the addition of secondary school children in Years 7, 8, 9, 10 and 11 to the programme. This includes those that are home-schooled and other children not in mainstream education.

Providers should ensure they commence vaccinations as early as possible after the flu vaccine becomes available and complete by 15 December in line with the other school aged cohorts already announced.

ACCELERATED ACCESS TO RECORDS

Further to the article in the <u>June LMC newsletter</u>, we have received the following update from General Practitioners Committee (GPC) England:

GPC England continues to challenge the government on the accelerated access programme which is intent on compelling GPs to give all patients access online to their GP-held medical record before GPs and patients are ready. GPC is particularly concerned about harm being caused to patients through patients accessing their medical records and seeing new information about their health prematurely, for example, a diagnosis of lung cancer prior to it being discussed with the doctor.

GPC needs your help. If you are aware of any examples of this happening in your practice or in a practice in your area, please can you get in touch urgently and provide details of the incident. This information will be invaluable in enabling us to substantiate our concerns with real examples. The information can be anonymised and provided anonymously if that is preferred. Telecoms

It would be particularly useful to hear from practices that went live with the accelerated access programme and whether any harms caused through the release of information occurred with patients who hadn't initially asked for access, but had been granted it as part of the accelerated access programme. If it was felt the inappropriate or early release of information occurred due to a failure in redaction capabilities (or an oversight due to lack of training) it would be useful to know that too.

CHANGE TO THE CORONIAL REFERRAL PROCESS

Further to the article in the <u>June LMC newsletter</u>, Mrs Tanyka Rawden, HM Senior Coroner, South Yorkshire (West) is distributing a letter to all GPs across her jurisdiction giving further details. The content of the letter is as follows:

The referral portal

I am writing to advise you about a forthcoming change to the way in which deaths are referred to me.

The current system is that all referrals are received via email and the details form that email are inputted into my case management system by a coroner's officer.

A recent review has identified that 3,483 hours are spent per annum inputting death referrals into my case management system. This equates to losing almost two investigative officers per week to this administrative task.

You may be aware that there have been significant delays in investigating deaths referred to me recently. This causes distress to the bereaved, the potential of lost evidence, and capacity issues in local mortuaries.

In order to improve the service we provide to the bereaved and ensure our resources are used effectively, from 9 October 2023 all referrals to me will be made via a website referral portal. Referrals can be made via the portal before this date, but referrals will only be accepted via the portal from 9 October 2023.

The portal is available twenty-four hours a day, seven days a week. You are able to save or download the information inputted should you need a copy of the referral for your records.

You will be provided with a step by step guide to assist you in making a referral along with a unique code for your profession by the end of July 2023.

You will also be provided with an email address to contact should you have any difficulties with the referral.

STATEMENT ON THE PRIMARY CARE DOCTOR PROPOSAL

The General Practitioners Committee (GPC) has issued a <u>statement</u> in response to proposals from the General Medical Council (GMC) and NHS England (NHSE) for regulatory change and the creation of a "primary care doctor".

The GPC does not believe that general practice currently has the staff, financial or premises resources to accommodate an intake of "primary care doctors", nor do they believe that the proposals are being designed to benefit doctors who want to make the switch into primary care.

The statement outlines their concerns with the different ways in which "primary care doctors" could be introduced.

CALL TO ACTION FOR GENERAL PRACTICE

General Practitioners Committee (GPC) England has published a <u>Call to Action (CTA) for General Practice</u>, which is their strategy for what is needed to provide high-quality care for patients, and which compiles what they want to see in the next round of contract negotiations, including:

- More investment in general practice to deliver better local, long-term care for patients.
- Safer, greener infrastructure to bring general practices into the 21st century and provide better care.
- More control to practices so they can work collaboratively at scale, while offering continuity of care.
- The necessary time to provide better quality care by removing unnecessary bureaucracy and box-ticking.
- Support with expanding the GP workforce to achieve the equivalent of at least 40k full-time, qualified GPs in post by 2030/31.
