VIRTUAL MULTISPECIALTY COMMUNITY PROVIDERS (MCPS) AND ALLIANCE AGREEMENTS

As you will be aware, in October 2015 the Government announced the intention to create a new 'voluntary' contract to be used by GPs in England, working with others, that would provide 'at scale' general practice (ie over populations of at least 30-50k patients, but possibly larger depending on the services they cover).

Over the last 18 months this has been developed by NHS England via the MCP Contract Development Group, resulting in the publication of the MCP emerging care model and contract framework, followed by the full MCP contract and a suite of documents covering the Virtual, Partially-Integrated and Fully-Integrated MCP models. It is expected that NHS England will be updating these documents in the coming months.

TRAINING FEE FOR IMPLANT AND IUD FITTERS

Queries were raised with the LMC regarding training fees and whether these could be centrally funded. The following clarification has been received:

- For recertification via the practical sessions offered by the Sexual Health Service, LARC fitters can claim £150 from Public Health.
- Such claims should be included on the practice's usual quarterly LARC invoice.
- An offer has also been made to offer £75 for clinicians to undertake the eKA online assessment.
