COVID THERAPEUTICS: GUIDANCE FOR GPS

As many of you will be aware, the current commissioning of Covid Medicine Delivery Units (CMDUs) ends on 27 June. The British Medical Association (BMA) has issued <u>guidance</u> clarifying the view that it is not appropriate for every GP to be required to start prescribing these medications. This is due to the complexity of the current cohort of eligible patients and the nature of the medications themselves.

DELIVERY PLAN FOR RECOVERING ACCESS TO PRIMARY CARE: LMC COMMENTARY

The GP recovery plan was published last month, and the LMC has had an opportunity to go through the details and summarise the main issues for General Practice in Sheffield.

Taken together with the imposed General Medical Services (GMS) contract changes for 2023/24, one can struggle to spot the positives! The logic of both is flawed at best and there is not much in it that will support General Practice in a sustainable way going forward. The LMC is continuing to engage the commissioners to discuss the implementation in Sheffield.

MANDATORY TRAINING ON LEARNING DISABILITY AND AUTISM

All GP practices in England must ensure their staff receive training in learning disability and autism, including how to interact appropriately with people with a learning disability and autistic people. This requirement was introduced by the Health and Care Act 2022 in July last year.

The government's preferred training programme is the <u>Oliver McGowan Mandatory Training on Learning Disability and Autism.</u> However, the Act <u>does not</u> specify a training package or course for staff. The Care Quality Commission (CQC) <u>cannot tell practices</u> specifically how to meet their legal requirements in relation to training, and while NHS England and Integrated Care Boards may share the government's training programme preference and encourage uptake, it is ultimately for practices to determine how their staff are trained to meet their legal requirements.

EXTENDED ACCESS HUBS REFERRALS

Concerns were raised with the LMC regarding patient referrals not being actioned by Extended Access Hub staff.

Cara Brazier, Head of Service - Primary Care at Scale, has provided a helpful update, noting that a protocol has recently been implemented whereby all routine referrals and urgent 2 week wait referrals are completed electronically and fed directly into the patient's record for action, hopefully more easily, by the practice. The change was made as a very small number of referrals had not been completed following the process in use prior to the changes.

If practices experience any difficulties with referrals generated by Extended Access Hub staff, it has been suggested that feedback is emailed to pcs.pcasfeedback@nhs.net.

OPENSAFELY

In recent months the Digital Transformation Policy Group at the General Practitioners Committee (GPC), along with the Joint GP IT Committee, have been providing scrutiny to the forthcoming Data Provision Notice (to be sent under the COVID-19 Directions from the Secretary of State for Health and Social Care) that will allow OpenSAFELY to continue to operate as a Trusted Research Environment (TRE) once its COPI permission expires on 1 July 2023. It has been a complex process with regard to information governance.

Practices will not need to do anything and formal communication from NHS England explaining the evolving legal basis for operation is expected soon.

MEDICAL EXAMINER (ME) SCRUTINY OF DEATH PROCESS

The General Practitioners Committee (GPC) met with the National Medical Examiner (NME) recently to express concerns that the processes in place for ME scrutiny of death is placing undue burden on practices and is unremunerated.

As the NME does not believe this to be the case, the GPC is requesting feedback as to how the system is working - both positive and negative feedback would be welcome - as well as any comments on the introduction of automated systems and / or the continued need for practices to complete paperwork. ACCELERATED ACCESS TO RECORDS

Following the imposition of the GP contract, practices will be expected to provide automatic prospective record access to all patients from 31 October 2023.

REDUCTION IN NHS PROPERTY SERVICES (NHSPS) SERVICE CHARGE CLAIMS

The British Medical Association (BMA) has assisted 5 GP practices in significantly reducing years of unsubstantiated service charge claims demanded by NHSPS. The landmark cases, brought in 2020, were started after practices began to struggle to afford soaring service charges set by NHSPS, despite there being no prior agreement or explanation for the price increase.

BMA lawyers challenged NHSPS on the legal basis on which the charges were being imposed, and the magnitude of the fees.
