#### MISFILED INFORMATION IN MEDICAL RECORDS

It has been suggested that LMCs remind practices of the potential problems arising from misfiled information being released in breach of the Data Protection Act (DPA). If a practice responds to a request for records under the DPA but accidentally sends information that has been misfiled relating to another patient, the practice would be in breach of the DPA by virtue of releasing confidential health information.

When releasing records practices have to make numerous checks, such as ensuring there is no information likely to cause serious physical or mental harm to the patient or another person, or information that relates to a third party who has not given consent for disclosure (where that third party is not a health professional who has cared for the patient). The LMC would urge all practices to ensure that a system is in to check for misfiled place information when carrying out these checks.

#### LIBERATING THE NHS: AN INFORMATION REVOLUTION

On 18 October 2010 the consultation *Liberating the NHS: An Information Revolution* commenced.

The consultation document states that the Government's vision is one of health and adult social care information being liberated from a closed, bureaucratic system in order to serve patients and the public, and to help drive better care, improving outcomes, innovation and the better use of resources. The consultation document is divided into broad chapters covering:

- Information for patients, service users, carers and the public;
- Information for improved outcomes;
- Information for professionals;

- Information for autonomy, accountability and democratic legitimacy;
- Setting the direction the information strategy.

#### LIBERATING THE NHS: GREATER CHOICE AND CONTROL

On 18 October 2010 the consultation Liberating the NHS: Greater Choice and Control commenced. The Government's White Paper, Equity and Excellence: liberating the NHS sets out proposals which envisage a presumption of greater choice and control over care and treatment. This consultation explains the proposals in more detail and seeks views on:

- Proposals for offering more choice for patients and service users;
- How shared decision making can become the norm;
- How it can happen: information, 'any willing provider' and other tools;
- Making safe and sustainable choices.

### QOF INDICATOR DIABETES 23

Following an article published by GP Notebook on 30 September titled Targeting Type diabetes. 2 clarification has been received from the GPC that there have been no changes to the HbA1c targets for diabetes in 2010/2011. NICE published their menu of recommended changes on 3 August Page 2 of 2

which 2010. included а recommendation to increase the HbA1c target for DM23 from 7, as it is currently, to 7.5. In line with the new QOF process, this menu of recommendations is now subject to through formal agreement negotiations between NHS Employers (NHSE) and the GPC. Once negotiations have concluded, any changes to the QOF will be published and the QOF guidance will be updated and published on the relevant websites ahead of the new QOF year.
